# Five Local Clubs Contest 2003 Millennium Cup

Five teams in South West London will compete from late April through until September 2003 in the third Millennium Cup, a friendly inter-club team competition between the tennis clubs in the general area of Streatham in which Grafton, Norbury Park, Telford Park, Wigmore and Woodfield Grove compete for the honour of winning the magnificent crystal trophy each year.

The event is played on a league basis to determine the two best clubs who will contest the final to be played on Saturday 20<sup>th</sup> September with the first ties being held on 26<sup>th</sup> April.

Designed to encourage new players into competitive play and provide them with match experience within a friendly local environment, the Millennium Cup involves participants of all ages in nine different categories. Each team will field players to compete in the following matches at each tie:

Singles 16 & Under Boys 16 & Under Girls Men's Open (no age restriction) Women's Open (no age restriction) 45 & Over Men's 40 & Over Women's Doubles Men's (no age restrictions) Women's (no age restrictions) Mixed (no age restrictions)

The inaugural Millennium Cup in 2001 was won by Wigmore Lawn Tennis Club who had to hand the trophy over to Norbury Park Lawn Tennis Club last year after an extremely close and thrilling final.

The Millennium Cup Competition was created to foster goodwill between participating clubs as well as being a means to promote new activities within each club for the involvement of members, to increase interest in local clubs and encourage participation in the game of tennis by the wider community.
